The Curriculum Subcommittee met on April 3, 2013. The following items were addressed: (1)Update on Smarter Balanced Pilot Testing –Feedback, students are having difficulty using the technology tools, therefore, teachers and students will need instruction on technology skills specific to Smarter Balanced testing. (2) Sample Smarter Balanced Test Items – Sample questions from the Smarter Balanced website were presented to subcommittee members. (3) Website Updates – Subcommittee members were presented with updates on the district website including curriculum, high school school-wide standards and Student Success Plans which included links to Navigation 101. Dr. Tenney is to contact the library media specialist to set up technology courses for adults. (4) Summer School Update – July 8th is the start of summer school which for most grades will consist of 5 weeks. Education Connection will host a free 2-week program for grades 3 – 5. Middle and high schools will be Odysseyware-based. (5) Common Core Workshops – Two Common Core workshops are scheduled for parents: April 24th at 5:30 p.m. at Harry S. Fisher Elementary School and May 14th at 7 p.m. at Plymouth Center School.

Mr. Travers is awaiting a report from the committee; (2) Mr. Travers reviewed the "Hall" Behavioral Lesson Plan; (3) CMT testing went very well; (4) The Math Smarter Balanced Assessments for grade 8 students will be given on April 1st – 12th; (5) On February 21st the Board's budget for 2013 – 2014 was presented to the Board of Finance by Mr. Santogatta.
