A. Curriculum - Mrs. Kulesa

The Curriculum Subcommittee met on September 5, 2012 and discussed the following: (a) Common Core State Standards Instructional Shifts: major shifts of the Common Core State Standards in English Language Arts and Mathematics; (b & c) Connecticut No Child Left Behind Waiver & Connecticut's New Accountability System – explanation of Connecticut's new accountability system can be found at http://www.sde.ct.gov/sde/cwp/view.asp?a=2683&Q=334346. The subcommittee examined Plymouth's District Performance Indicators (DPIs) and each school's School Performance indicators (SPIs) and targets for 2012 – 2013.

B. Facilities - Mr. Engle

C. Finance - Mr. Bourbonniere

The Finance Subcommittee met prior to the Board Meeting and agreed to forward the following to the Town of Plymouth Board of Finance: (a) the Final Accounts by Facilities Report for the end of the year 2011 – 2012 and (b) the Accounts by Facilities Report for the month of August.

The Board gave the Town of Plymouth \$100,000; \$119,000 was placed in a sinking fund and \$12,000 was used to fill the Town's oil tanks.

10. ADMINISTRATIVE REPORTS/REQUESTS/INFORMATION

Dr. Tenney – Director of Curriculum & Instruction

(a) Education Connection, Plymouth Schools win grant for fitness – the Plymouth middle and high schools together with the Litchfield Education Connection received one of 56 national grants to be put toward fitness and nutrition. The grant, the Carroll M. White Grant, is in the amount of approximately \$300,000 a year and is for three years. It began on August 3rd. The purpose of the grant is to help students meet the state goals for fitness. (b) Grants from Thomaston Savings Bank for books for the elementary schools and Nooks for the middle school. (c) The high school and middle school began their advisories and the student success plans. And (d) CMT and CAPT scores have been sent home.

Mr. Parenti - Director of Pupil Personnel

(1) focusing on developing IEP's that would stand up in due process; focusing on data to drive the IEP development; PD coming up on how to use data efficiently and effectively; Leadership Conference – School Personnel Development Grant – 3 year grant through Connecticut SERC which will help to implement SRBI in the middle school and will begin with PBIS in the fall and then will work on literacy. A complete analysis will be done of what the district has and what it does not have; and the new high school transition program wherein local businesses supply vocational experiences to students between the ages of 18-21. A presentation on the transition program will be given to the Board at its October meeting.

Mr. Trudeau – Director of Technology

It's been a busy summer. (a) maintained updates to some of the computer labs in the district; (b) installation of interactive white boards down through kindergarten; (c) laptop carts, and (d) wireless is up and running. Thank you to: Matt, Jason and Mr. Maslak for tonight's broadcast on Plymouth 16.

Mr. Perugino indicated that he has received many positive comments on Mr. Trudeau's work at the Town Hall.

Mr. Santogatta – Business Manager

The Finance Subcommittee met prior to the Board Meeting. Some of the items discussed were: \$100,000 was returned to the Town and \$119,000 was placed in a sinking fund; a number of summer projects (a) windows and doors at the middle school; (b) boilers at Harry S. Fisher Elementary School; (c) repair chimney, lavatories; (d) review of energy program (compared to August of 2009 to August of 2012 there was 51% less of kilowatt usage in 2012.)

Dr. Distasio – Superintendent

Dr. Distasio addressed the following: (a) "thank you" administrators, principals and staff for a well-organized and smooth school opening; to Mr. Santogatta, Mr. Dennis and the custodial staff "thank you" for doing such a great job in preparing our buildings; (b) the opening day meeting for staff was held on August 22 in the Terryville High School auditorium and Mrs. DiVenere was introduced as Teacher of the Year; Mrs. Jobbagy presented an opening speech on behalf of the PTA Council; **Dr. Tenney** presented an overview of the new Common Core and organized the professional development session for the teachers; Mr. Parenti outlined the Scientific Research Based Intervention and developed the workshops for our paraprofessionals; 18 new staff members had perfect attendance last year; "thank you" to Mrs. Aiudi, Mrs. Basile and *Mrs. Borda* for helping to plan the events for the opening day meeting; (c) "thank you" to Mrs. Aiudi for organizing our students who worked at the Terryville Fair; (d) parents are encouraged to discuss the important issue of bicycle safety with the children and drivers were asked to drive carefully and to be cognizant of children riding their bicycles; and (e) as he looks forward to the next and last 4 months in the district he is looking forward to helping Ms. Cruz make her transition to the Plymouth School District a very seamless and smooth process.
