E. Proposed Retirement Incentive

MOTION: To approve the Memorandum of Agreement with the teacher's union Regarding a Voluntary Early Retirement Incentive Plan. Motion Mr. Gentile, seconded Mr. Perugino.

Discussion: Mr. Perugino thanked the superintendent and Mr. Santogatta for all of the work they did in preparing the early retirement incentive.

Ms. Cruz highlighted some of the material contained in the document. The Board would pay to each early retirement participant the total sum of \$15,000, in 3 equal installments to be paid in accordance with the following schedule:

- 1. on or about July 15, 2014
- 2. on or about July 15, 2015
- 3. on or about July 15, 2016

Certain requirements listed are: the employee would have to work for the Plymouth Public Schools for at least 12 years and be eligible for retirement.
