B. Addendum to Agreement for Child Nutrition Programs (ED-099) New Business

Public Act 06-63, An Act concerning Healthy Food and Beverages in Schools, requires that all Connecticut Public School Districts that are eligible to participate in the healthy food certification take action to certify whether all food items sold to students will or will not meet Connecticut Nutritional Standards.

MOTION: In accordance with Public Act 06-63 of the Connecticut General Statutes, the Plymouth Board of Education hereby authorizes the Superintendent to execute the Addendum to Agreement for Child Nutrition Programs (ED-099) and to execute any claims for reimbursement. Motion Mr. Perugino, seconded Dr. Wheeler. At this time, the chair called for a roll vote. Certification Statement

MOTION: Pursuant to Section 10-215f of the Connecticut General Statutes, the Plymouth Board of Education hereby certifies that all food items offered for sale to students in the school(s) under its jurisdiction, and not exempted from the Connecticut Nutrition Standards published by the Connecticut State Department of Education will meet said standards during the period of July 1, 2014 through June 30, 2015. Such certification shall include all food offered for sale to students separately from reimbursable meals at all times and from all sources, including but not limited to school stores, vending machines, school cafeterias, and any fundraising activities on school premises, whether or not school sponsored. Motion Dr. Wheeler, seconded Mrs. Kulesa. At this time, the chair called for a roll vote. The following individuals voted in favor of the motion, Mr. Melchionna, Mr. Perugino, Mr. Gentile, Mr. Orsini, Mr. Goodwin, Dr. Wheeler and Mrs. Kulesa motion passed unanimously.

Exemption Statement

MOTION: Pursuant to Section 10-215f of the Connecticut General Statutes, the Plymouth Board of Education will permit the sale of items excluded from certification as long as such sale is in conjunction with an event occurring after the end of the regular day or on the weekend; such sale is at the location of the event; and such food is not sold from a vending machine or school store. Motion Mrs. Kulesa, seconded Mr. Perugino. At this time, the chair called for a roll vote. Amendment to Agreement for Child Nutrition Programs (ED-099)
